Continue discussion of how to grow our town. Currently there are 782 residents in the Town of Red Cross per the latest census. Michael presented his list of benefits to joining our town. 1. Tax rate is low-currently \$.16 per \$100. 2. Taxes pay for local fire department taxes. 3. Local roll out trash service is provided. 4. Residents don't have to pay county trash/solid waste fees. 5. Local town leadership is accessible to residents. 6. It's free to petition for annexation.

Board agreed with these points and look forward to sending adjoining landowners a flyer to encourage them to join our town.

New Business:

-Resident made a suggestion that our R/A should be at least 1 acre. Currently R/A is 40,000 sq. feet. Board recommends we amend the zoning guidelines to up the R/A requirement to 43,560 sq. feet (1 full acre).

-Michael Sandy suggested that we look at cleaning up our zoning map. There are seven properties that have been zoned GB or HB for a very long time and has not been used as business. The board will send letters to those owners to recommend that they allow for Zoning back to R/A. There are four properties that are currently R/A or C/B that need to be moved into the T/C (Town Center) district. Letters will be sent to the owners to invite their comments. These changes would allow for better continuity in our zoning maps and for future continuity in keeping business clustered near Town Center. Planning Board agreed with this suggestion.
