The fuel surcharge has had a big impact in the amount paid for waste collection in the 2010-2011 budget for this service remains at \$43,000, same as the previous year. Police protection has increased from \$15,000 to \$18,000 for the 2010-2011 Budget. However, the General Funds decreased from \$39, 560 to \$26,700. Council member Jordan believes the zoning fund should be decrease from \$16,000 to \$14,000 since Carol Rhea has completed most of her work on the land use plan .Council member Jordan believes this can be done without increasing the tax rate from .16 per \$100 valuation which as been the tax rate for the Town since the incorporation in August, 1992.The Council will have a Public Hearing at the June Town Council Meeting to vote on the 2010-2011 Budget. Council member Jordan we have a conservative budget, since we can project how much money will be coming in, but hopefully we will be pleasantly surprised as we have been in the past. The Council also discussed securing off site location for recycle items. He has discussed with other towns on their positions on waste disposable and recycling. Also grant money may be available for this project. A workshop maybe needed when additional information is received on waste collection and recycling.

The Mayor asked for comments from the public.
